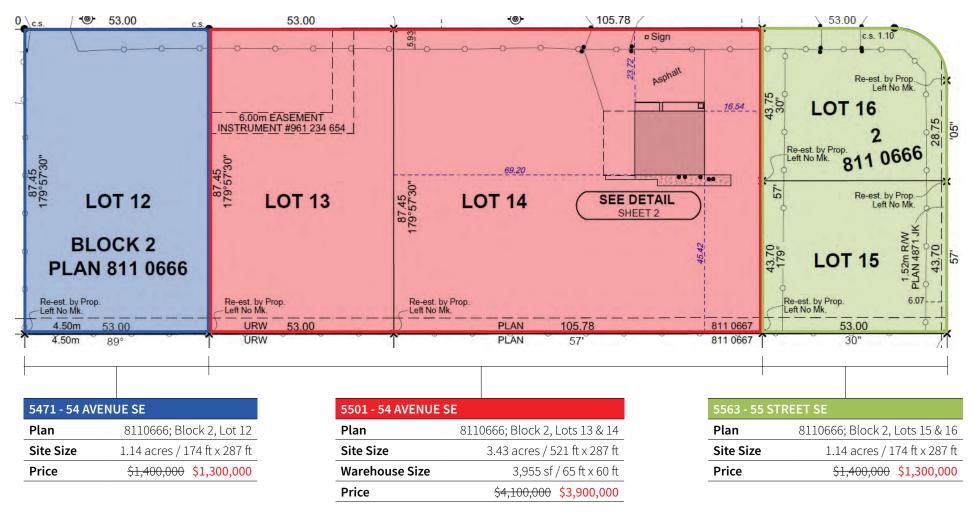

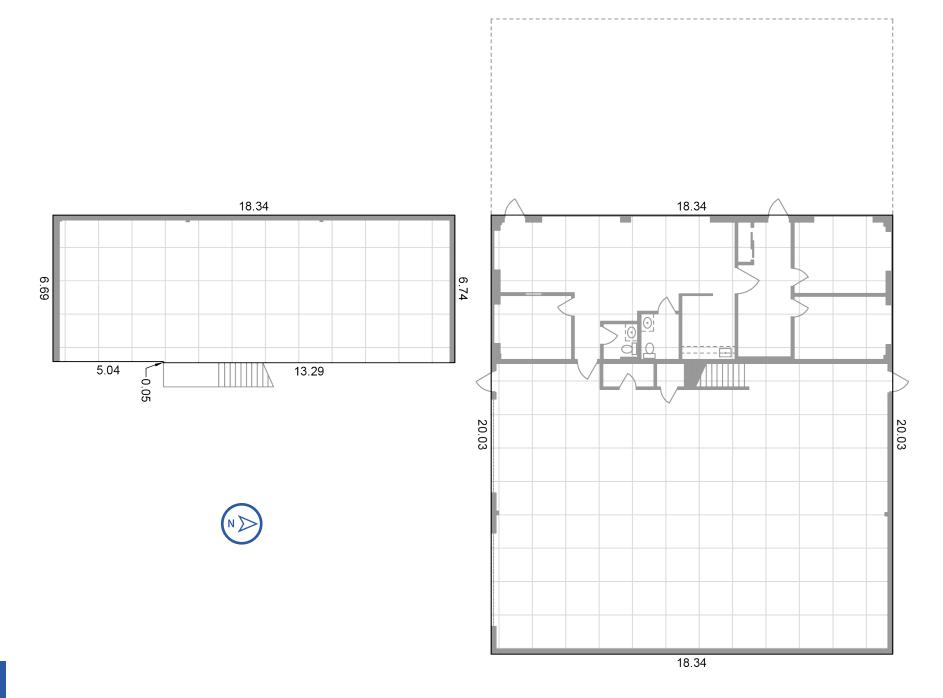








BUILDING PLAN
